The Structural Insulated Panel Association (SIPA) is hosting the twentieth annual Building Excellence Awards to recognize association members that build exemplary projects using structural insulated panels (SIPs). The competition allows SIPA members to showcase their best work while demonstrating the design flexibility, sustainability and energy

efficiency possible with SIP construction.





March 6th, 7^{th} and 8^{th} / PHOENIX, AZ Winning entries will be showcased at the 2023 SIPA Annual Meeting and SelectSIPs EXPO.



Homes and commercial buildings completed between January 1, 2022 and December 31, 2022 are eligible.

Award Categories:

- High Performance (any size or use category judged only on special High-Performance features or certifications)
- Single Family 'Small House' under 900 sq. ft.
- Single Family Homes over 3,000 sq. ft.
- Single Family Homes under 3,000 sq. ft.
- Multifamily
- Agricultural
- Commercial/Industrial/Institutional Buildings under 10,000 sq. ft.
- Commercial/Industrial/Institutional Buildings over 10,000 sq. ft.
- Renovations (residential or commercial, includes additions and retrofit insulated panels)
- Affordable Housing (excludes multifamily, home ownership cost must be at or below 50% of median income for location)

Who is Eligible?

- The submitting company must be a current SIPA member in good standing
- Structural insulated panels must be used on a minimum of 50% of the building envelope, determined by square footage of exterior walls and roof
- The SIPs used on the project must be provided by a SIPA member manufacturer
- Installers, designers or other parties involved in the project who are not SIPA members will not be recognized in awards materials.
 However, builders or architects may apply for membership with their entry, but must be full members in good standing prior to the closing date for the entry to receive recognition.
- Project must be <u>completed</u> between January 1, 2022 and December 31, 2022

Winning Entries

- One winner will be chosen from each category. From the category winners, an Overall Competition Winner and a Runner-Up will be named.
- Judges may hand out Honorable Mentions at their discretion
- Winners will be recognized at the 2023 SIPA SelectSIPs EXPO (Annual Meeting) March 6th - 8th 2023, Phoenix, Arizona.
- SIPA will promote the winning entries on the SIPA website and issue a press release to outside media

Guidelines

- Member companies may make multiple entries, but a separate entry form must be completed for each entry (except for same project also submitted to High Performance category)
- SIPA has the right to use the photos to promote SIPs to the construction industry. All entries will be displayed on the SIPA website.
- The deadline for entries is January 18, 2023. All entries must be received at the SIPA office on or before that date.

The following information and documentation are REQUIRED. Entries without the required items will not be considered.

- Completed and signed application
- A minimum of two photos showing different views of the completed project
- Photographs must be submitted in digital form and be at least 2400 x 3000 pixels, or 8" x 10" at 300 dpi
- Residential projects are encouraged to have a HERS Index calculated by a RESNET certified home energy rater. High Performance category projects <u>must</u> present a HERS Index with blower door data. Commercial High-Performance projects <u>must</u> provide other documentation of energy efficiency.

Additional documentation is not required but is highly recommended to give the judges a clear picture of the project's overall design, sustainability, systems integration, and energy efficiency.

- Additional photos showing the construction process and SIP installation
- Documentation of energy efficiency, such as a HERS report, blower door test results, utility bill data, or infrared thermography
- A thorough description of energy-efficient technologies other than SIPs, as well as other innovative or sustainable features
- Comments from the building owners regarding their satisfaction with the building
- A floor plan of the project. A single page line drawing no larger than 17" x 22" in size is sufficient. Please do not send full blueprints.



Judging Criteria

Each entry will be judged on the following criteria:

- Design and structural engineering innovation
- Creative use of SIP construction
- Environmental sustainability

New High Performance Category criteria:

- Projects can compete both here and in specific building type category
- Only features pertaining to eco-efficiency, health, resilience, and renewable energy are considered here
- Energy efficiency (quantified by HERS Index, blower door and other data)

Describe the end use of the building:

The project is a single family home for Robert and Mary Ann Clough who retired to Michigan from North Carolina. The homeowners wanted a high performing home to live their days of retirement.

How did SIP construction help you get this job?

The homeowners retired from aerospace engineering and understood the benefits of using a progressive material to provide energy savings through their days of retirement. I was contacted by the homeowners through a referral from the panel manufacturer to design a home that meets the energy requirements. My practice specifically focuses on high performance residential using SIPs.

SIP wall thickness and core material: 6.5" with EPS core (U-0.039)

SIP roof thickness and core material: 10.25" with EPS core (U-027)

Describe the benefits of using SIPs on this project. Did SIPs help save time, labor, construction costs, or energy?

SIPs became the end user energy hero on the project assisting in providing the home with an envelope that exceeded Michigan's stringent energy codes by 58.2% and a blower door test of 0.81 ACH @ 50 pascals, even with a wood burning fireplace insert.

The efficient design allowed for quick installation with the ability to dry-in the envelope before Michigan's harsh winter came in.

Construction costs were on-par with comparative projects in the area using conventional construction methods.

Describe any innovative design elements or structural engineering involved:

Southern exposure clerestory windows and overhangs designed for shading in the summer (passive solar) while providing reflected indirect lighting in the main living space. Basement constructed using insulated precast concrete panels (Superior Walls) providing continuous insulated envelope from basement slab to roof peak. Insulated storm shelter under front porch. Rainwater falls into a gravel french drain which is collected in a cistern for reuse. The gravel pre-filters the water. Performed Manual J Calculations early in the project to determine best strategy for envelope requirements and HVAC sizing. Utilized high lofted ceilings to underside of SIP roof for airy feel. Clerestory windows filter down into hallway to utilize natural daylighting to reduce the amount of lighting needed. All lighting is LED including low-voltage puck lighting on underside of roof panels.

Describe the HVAC system used on the project:

Entire home is conditioned in the summer with a 2-ton central condenser (13 SEER) and 48,000 BTU, 96 AFUE LP furnace. The home is supplementally heated by a enclosed (self contained) wood burning fireplace insert. Home is continuously ventilated with Energy Recovery Ventilator (ERV) providing 177 CFM in 10-hour increments, exceeding ASHRAE requirements for indoor air quality ventilation. The system was sized by Moonlight Architecture utilizing ACCA certified software. Ducts tested results 26 CFM @ 25 pascals.

Describe any other energy-saving materials used in the building envelope other than SIPs. List U-values of windows used and the U or R-value of any insulation materials. (judged only for High Performance Category)

- Insulated precast concrete foundation walls (Superior Walls) R-Value: 12.5 Sunrise Windows (EnergyStar) U-Factor: 0.27 ; SHGC: 0.26 (insulated frames with integral brick mould for tighter installation).
- Energy Star shingles, prepared for solar panel installation.

Please list any energy-efficient products or design features, such as lighting, hot water heating, appliances, passive solar (judged only for High Performance Category):

- 100% LED Lighting
- Passive solar heating and daylighting measures.
- ERV Ventilation

Were any solar panels installed on the project? If so, indicate the size of the system (judged only for High Performance Category):

No solar panels installed at final inspection, however the project is solar-ready. Panels anticipated to be installed within the next year. South roof plane exceeds area needed for Net-Zero.
