Additional comments:

Panelworks Plus is proud to have been part of this great building project. Since the building layout was complete before our involvement, several changes were needed to adapt SIPs into the design. Careful coordination was required to make best use of panels. By using Starwood LamPly roof trusses set at 8' O.C. and covering with 8' x 24' SIP roof panels, there was virtually no waste generated in the production of the roof panels. Sidewall panels were also 8' wide with support columns for the LamPly trusses being incorporated into the wall panels. Due to the height of the end walls at about 32', there was a considerable amount of glulam beams within the 10-1/4" SIPs required to provide adequate wind loading. In addition, one end wall also had large windows located high and glass overhead doors below that open from the tap room to an exterior dining area. The exterior was finished with Nova Brick and colored steel on the sidewalls, and a standing seam steel roof, ready for addition of PV panels in the future.
