- 1. SIP (structural insulated panel) exterior wall system reduces overall material usage and jobsite waste in turn reducing construction costs.
- Because of the SIPs construction method the shell in/dry in time was significantly
  reduced creating a time savings for the construction schedule and providing a higher
  quality end product by reducing exposure time to the outside elements.
- All of the SIP benefits noted above (time savings, labor, construction cost) result in a net energy savings.

Describe any innovative design elements or structural engineering involved:

- 1. Efficient floor plan with low impact footprint.
- 2. Covered or protected entry's to reduce water intrusion and long term rot.
- 3. Roof overhangs sized for the climate.

Duane – I never got around to writing a few comments in a letter for the SIPA contest. So I guess you will have to settle for an email?

Needless to say I love the new house. The layout is perfect for enjoying the river and the river views. The combination of indoor and outdoor entertaining space is fantastic. We had the SKOAC kayak club party on Saturday and comfortably had 40 guests enjoy the house. It is hard to separate out the energy use of the house from the separate home office, lab and shop. However the combined SIPs panel construction, T-mass basement walls and ground source geothermal heating and cooling has been very comfortable and very inexpensive.

The lab, shop and solarium office is of course much smaller than the house, but the solarium office no doubt is a bit hungry for heating and cooling energy. In spite of all that glass I have been able to heat and cool the combined square footage of about 4,700 square feet for less than \$200/month during the coldest below zero Minnesota weather, and I believe the highest cooling cost was about \$50/month for the relentless 100 degree heat that we had for much of last summer. All that while keeping the thermostat set in the 65-75 degree range. No need to dial the thermostat up or down, even in the dead of winter or during the hottest summer day the heating and cooling system kicks in only infrequently while keeping within a very comfortable temperature range.

The spray foam roof insulation, the T-mass basement and SIPs construction are all very quiet as well. I never hear any outside traffic noise and there is never a problem with any noise from rain or hail on the metal roof. Make sure you include the information on rainwater capture, the rain garden and the hopefully soon to arrive "no mow lawn". I have also swapped out all the lighting with the exception of decorative lighting over the stairs and dining room table with LED and CFL lighting. I saw in some of the other home listings on the SIPA site that efficient lighting was one of the items listed.
